CBIC should take the trade bodies into confidence and test run the project at small ICDs and then take it to minor ports before launching them directly at major ports, which causes lot of delays and uncertainties.

Mr Lapsiaa added that the importers/exporters needed to be graded/ranked based on their compliance and in following ethical business practices. He said that it was imperative for the importers/exporters to be serious about the knowledge of Customs initiatives, laws, notification, etc. and, also, in their ap-

pointing qualified and reputed vendors as against going for L1 tender systems and giving away their clearances to unqualified and tainted vendors, to cut costs. "This", he said, "vitiated the environment and resulted in host of unethical practices flourishing".

Mr Lapsiaa also cited lack of Customs infrastructure at minor ports and urged the Shipping Ministry to ensure that proper full-fledged Customs station was in place at the minor ports, with officers having judicial and executive powers before making the port operational. He pointed out the hardships trade had to face at minor ports like Pipavav, Hazira, Haldia and others.

Dignitaries from the revenue side who shared their views with the delegates included Mr Bani Bhattacharya, Principal Chief Commissioner of Customs, Mumbai, who appreciated the concerns expressed by Mr Lapsiaa and assured him and the gathering of the department taking a note of the same. He cited some of the key initiatives undertaken by the Customs and urged the trade to make full use of them. He particularly mentioned of the AEO programme and the deferred duty payment scheme, which he urged all the importers and exporters to avail of.

The meeting was chaired by Mr Nadir Godrej, who in his inimitable style, rendered a wonderful poem covering all the issues and points of liquid bulk trade vis-à-vis the Customs and port. He received a thunderous applause from the huge gathering after the recitation of the well-conceived poem.

Mr S. Thirunavakarassu, Sr Manager - Indirect Taxation, Hindustan Unilever Ltd, spoke on the good trade facilitation measures undertaken by the Customs and also requested them to expedite the classification and valuation issues, which at times were causing alarming delays. He complimented AILBIEA and also assured the Customs
